## The Problem with General-Purpose AI for Legal Research

In law, accuracy is critical: a single fabricated case citation can lead to professional sanctions, as seen when general-purpose chatbots were used for legal research. **RAG** addresses this by grounding AI in authoritative, validated legal databases rather than relying on its own memory—retrieving verified sources instead of guessing.

## How RAG Solves Legal Hallucinations

### Verification Against Binding Authority

General LLMs may blend laws across jurisdictions, while RAG systems retrieve information only from verified sources.

### Elimination of Fictional References

A common hallucination is the invention of non-existent cases. RAG prevents this by grounding references in retrieved documents.

### No Knowledge Cutoff

Laws and precedents change frequently. An LLM trained in 2025 cannot know about a 2026 ruling. A RAG system can index a new court opinion the same day it is released.

### Jurisdiction Control

eulaw.ai allows you to limit research to selected European jurisdictions plus "International" covering treaties and documents with legal significance in Europe.

**Oxford Academic** study "Large Legal Fictions" shows general LLMs hallucinate over 50% of the time on legal queries. **Stanford HAI** research confirms RAG tools (Lexis+, Westlaw) dramatically reduce errors versus general models.
